The Management Board of ARCUS S.A. hereby discloses additional information to the current report No 12/2011 of 26 May 2011 as regards Mr. Marek Czeredys – the Chairman of the Supervisory Board who was appointed by the Resolution No 22 and No 27 of the Ordinary General Meeting of Shareholders and as regards Mr. Dominik Czajewski who was also appointed on 26 May 2011 at the Ordinary General Meeting by the Resolution No 23. The Supervisory Board discloses the professional bios of Mr. Marek Czeredys and Mr. Dominik Czajewski.

The professional bios of re-appointed members of the Supervisory Board: Mr. Michał Słoniewski, Mr. Sławomir Jakszuk and Mr. Ryszard Barski were published in previous current reports.

Marek Czeredys

Mr. Marek Czeredys was a partner of ARCUS Ltd. since 1987. Mr. Marek Czeredys is 57 and was graduated in 1978 from Warsaw University of Life Sciences Faculty of Veterinary. Mr. Marek Czeredys holds a veterinary degree.

He started his professional career in PZLZ (National Medicinal Plants for Animals) in Radzymin, where for 9 years he worked as Head of the Medicinal Plant. In 1987, Mr. Marek Czeredys joined ARCUS Ltd. as a partner and became Commercial Director. In 1992-2005, Mr. Marek Czeredys was a President of ARCUS Ltd. Management Board. In 1999 he acquired 99% of the company's stakes.

In 2005-2010 he was a Chairman of the Supervisory Board of Zakłady Doświadczalne Instytutu Zootechniki Mełno (Experimental Plants of Animal Production Institute Mełno Ltd.), Chairman of Inforsys S.A. Supervisory Board and Chairman of ARCUS S.A. Supervisory Board.

MMR INVEST S.A.R.L is a major shareholder of ARCUS S.A. Mr. Marek Czeredys is a dominant shareholder of MMR INVEST S.A.R.L.

In accordance with the statement submitted by Mr. Marek Czeredys, his son – Michał Czeredys is a President of ARCUS S.A. Management Board. Apart from that fact, there are no relations of family nature between Mr. Marek Czeredys and second Member of Issuer's Management Board and other Members of Issuer's Supervisory Board. Moreover, Mr. Marek Czeredys is not listed in the Insolvent Debtors Register maintained pursuant to the Act on the National Court Register.

Mr. Marek Czeredys does not meet the criteria of independence of the Supervisory Board Member arising from the Best Practices of WSE listed Companies.

Dominik Czajewski

Mr. Dominik Czajewski is a specialist in the field of operational and financial restructuring of large companies and capital groups. He is also involved in various issues regarding development strategies and building company value. He worked as a manager and consultant for the largest corporations in Central Europe: Orlen, CEZ, PGNiG, Masterlink, Poczta Polska, PZU, Polimex-Mostostal. For several years hew was a Director responsible for programs aimed at improving the operational effectiveness in Warsaw office of the international consulting firm – A.T. Kearney. Mr. Dominik Czajewski has a degree in economics (University of Management, Warsaw School of Economics) and Master of Business Administration degree (TVU London). He also completed number of management courses in Poland and abroad, among others in United States of America (Harvard Business School, Wharton School, Kellogg School of Management) and in Canada (McGill University).
